Ordinance 2017-4 Ordinance to approve the 2017 Permanent Appropriations

Ordinance- 2017-5 Ordinance to Sell Real Estate Located at 204 N. Sycamore St.

Ordinance 2009-2 An Ordinance to Prohibit Certain Nuisances in the Village

Unlicensed, junk, or disabled vehicles being parked and left on the streets. Please be advised that there is a Village Ordinance prohibiting this. If you have any of the above mentioned vehicles parked on the streets or at the parks, please be courteous and move these vehicles to private property. Failure to do so will result in enforcement of this ordinance.

Ordinance 2013-6 An Ordinance to Prohibit Certain Noxious Plants, Weeds, Grass, Bushes, and Trees

Any person owning or having control of lands including bank owned properties within the Village shall keep the lands clear of tall or noxious plants, weeds, and or grasses. Noxious plants, weeds, and or grasses in excess of twelve inches from where the noxious plant, weed, and or grass emerge from the soil or ground cover shall be considered a violation of section. Plants likely to produce viable seeds within the next 10-day period are noxious.



REMINDERS

Ordinance 2016-5 An Ordinance Enacting Section 93.60 of the Village Code to Prohibit Trespassing Signage

Trespassing Signage Prohibited (A) No person shall place, lean, nail, fasten or affix in any manner a sign upon the streets or public ways and public grounds in the Village without prior written approval from the Village Administrator. (B) No person shall affix a sign or notice to any utility or street light pole or structure in the Village.

TRASH PICK UP REMINDERS

Garbage pick-up will remain on Thursday mornings. Please place garbage out on Wednesday evening to ensure proper collection. Cans and bags must not exceed 50 pounds each.

Limit 6 cans per week

LARGE ITEMS

Each resident is permitted one large item per week per household. (Mattresses, Furniture, Appliances, etc.) REFRIGERATORS AND FREEZERS WILL NOT BE ACCEPTED. Mattresses and furniture must be covered in plastic in order for them to be picked up. You must call Community Sanitation one day in advanced to let them know you have a large item to be picked up.

YARD WASTE, TIRES, PAINT

Sticks should be bundled in 4' to 6' lengths.

Leaves must be in a bag or can.

Paint cans must be dried, lids off, and set out separately. Visible for the driver to see.

Batteries must be set out separately.

Sharps– Diabetic needles should be placed in a separate container and labeled.

NO TIRES unless arrangements have been made ahead of time to pay for removal.

Dead animal, combustible materials, or hazardous wastes will not be picked up.

Bulky materials such as drywall, concrete, bricks, dirt, or rock will not be picked up.

HOLIDAYS

Garbage pickup will be Thursday unless a major holiday falls within that week or on a Thursday. In this case garbage pick-up would occur on Friday.



RECYCLING BINS

Please do not use this as a trash bin. The following is a list of acceptable items that can be placed in the recycling bins.

Plastic bottles and jugs

Glass bottles and jars

Aluminum cans, steel cans, and lids

Paperboard (like cereal boxes)

Cardboard

Office paper, envelopes, junk mail

Newspapers, magazines, telephone books, catalogs

These items can be all mixed together. No separation is required. They just ask that all bottles, jugs, and cans be empty. Please flatten all cardboard, and empty, crush, and reattach lids on plastic bottles.

Never place medical sharps or needles, metal, batteries, tires, car parts, wood, electronics, foam, or food in the recycling bin.
