Water and Sewer Rate Update:

Per Ordinances No. 2020-07, No. 2020-08, and No. 2020-09, there will be a change in water, sewer, & trash rates.

Passed on 1/14/2021 and effective after 30 days following public notice.

The Water Base Rate adjusted from \$26.49 to \$26.75. The Sewer Base Rate adjusted from \$38.63 to \$39.02. The Trash Service adjusted from \$10.00 to \$12.00.

The new monthly base rates will be as follows:

- 0-2000 Gallons of Water \$26.75
- 0-2000 Gallons of Sewer \$39.02
- Trash Service- \$12.00
- Total New Minimum Monthly Bill \$77.77


